# **ANNUAL 2025 MEETING MINUTES**

February 2, 2025

Call to Order -Council President Clair Eslinger called the meeting to order at 11:27AM. He announced that the sign-in sheet had reached the minimum of 50 members present to begin the meeting. He also stated that a survey was being handed out to have congregational members share their thoughts on changing the Sunday service time to accommodate Pastor Janis' travel between churches.

Opening Prayer/Devotions - Pastor Janis Sloka led devotions which were based on Ecclesiastes 3:1-8. Prayer, reading of the mission statement and a blessing were given.

Review of the proposed agenda- no changes were made.

Approve Minutes - Mike Youngs made the motion, seconded by Mike Maki to accept the minutes presented from the January 28, 2024, Annual Meeting and the Special Congregational Meeting held February 25, 2024. Motion Carried.

Pastor's Report-Pastor Sloka shared information from the written report stating acts from 2024 that included 10 baptisms, 10 first communions, 4 confirmations, 3 weddings and 4 new family units. Also mentioned were membership transfers, funeral and memorial services and congregational statistics.

Pastor Sloka expressed thanks for having Our Savior, Max as part of our ministry partnership. He shared that it is not a parish, but a contracted arrangement where they are paying for pastoral services. Pastor Janis had been doing 1 Sunday service a month, confirmation, visitations and being present 1 day a week.

Faith Formation Director's Report- Holly Klemisch referred the congregation to the written report that presented information on Sunday School, Sonshine Friends, Vacation Bible School and LYO/LOL activities.

Committee Reports- Written reports from Confirmation Ministry, The Women of St. Paul for meetings and quilting, Altar Guild, Technology, Social Action, Fellowship, Prayer Shawl Ministry, and the Property Committee were viewed. Holly shared that the next Parish Education meeting was scheduled for February 10, 2025, and everyone was welcome.

Approval of Treasurer's Report- Clair Eslinger asked the congregation to view and ask questions on the treasurer's report. Mike Maki made the motion, seconded by Keith Thelan to accept the report as presented. Motion carried.

Old Business:

-The work in the sanctuary is completed.

New Business:

- Election of Council Members
  - Mike Youngs made a motion, seconded by Loree Jeffers, to nominate Debra Youngs, Traci Ruhland, and Leeann Wimer for another term. Motion Carried.
- Loree Jeffers made the motion, seconded by Jolene Splichal to cast a unanimous ballot for Deb, Traci and Leeann. Motion carried.
- Loree Jeffers made the motion, seconded by Holly Klemisch to nominate and cast a ballot for Kayla Macheledt for a 3-year council term. Motion carried.

- Compilation Report of the year 2023
  - Mike Youngs made the motion, seconded by Kayla Macheledt to approve the Compilation Report. Motion carried. Leeann Wimer shared that the review of finances and records was done by having someone review and check the responsible use of our finances.
- Approval of 2025 proposed budget- Council Member Jenny Collings stood to answer any questions on the proposed budget. Mark Torno asked why natural gas was listed in a lower amount. Jenny shared that the price had spiked but was now decreasing.
  - Andrew Haugen made the motion, seconded by Jolene Splichal, to approve the 2025 budget as presented. Motion Carried.

Ministry Partner Reports- Pastor Sloka referenced the reports in the meeting packet from The Western North Dakota Synod, Camp of the Cross Ministries and Lutheran Campus Ministries.

#### Closing Remarks:

Council President, Clair Eslinger expressed thanks and appreciation for Janis, Holly, Keith and others who helped with the work related to the water damage.

Holly shared that due to the claim, our insurance rates did go up but without another claim, they would decrease each year.

Janis expressed thanks to the family who donated the phone apps and equipment to monitor the heat and back room. This also helps with insurance costs.

Closing Prayer: Pastor Janis led a closing prayer and expressed a sincere thanks to the youth and Holly for the soup and sandwich lunch.

Clair asked that members contact Council Members with any questions or concerns. Seeing no other business, Clair adjourned the meeting.

## **2025 Faith Formation Director Year End Reports**

### **Sunday School**

We held an Easter Program consisting of songs and poems this year. Our Sunday School continued to follow the lectionary schedule the church follows. This allowed our kids to take what we heard in worship and learn more about it in Sunday School.

At the end of July, we held our annual Elementary Pool Party for Sunday School/Sonshine Friends families. We had between 25 -30 kids attend this event and we had hot dogs, chips, cookies, pop and water for the kids to snack on.

September 7th was the kick-off of Sunday School for the '25-26 School year. We have been averaging anywhere from 10 kids per week for Sunday School. Everyone starts out together and discusses what the theme was for the week then split into two age-based classrooms.

December 21st, we held our annual Christmas Program, which consisted of poems, songs, and the retelling of the nativity story where the kids 'built the nativity scene'.

We took two weeks off for Christmas break following this and resumed in January 2026.

### **Sonshine Friends**

I continue to split the kids into two different groups with Group A (K-2nd grade) meeting one week and Group B (3-6th grade) meeting the opposite weeks. Our group includes kids from other congregations as well. We have 20 kids in Group A and over 30 kids in group B. The theme for this year is the "Fruits of the Spirit". We have learned about 5 different fruits of the spirit so far. We also had a Christmas party for both groups separately this year. Our annual Friendsgiving was another success.

We took a Thanksgiving offering to cover the costs of supplies and snacks for the kids. The kids always amaze me with the things they can remember! They are wonderful young boys and girls, and we are blessed to lead them!

### **Vacation Bible School**

Our theme for VBS this year was "Camp Firelight: A Summer Camp Adventure with God" and was held from Tuesday, May 20 through Friday, May 23. Our program is always open to anyone in the community and surrounding areas. We had around 50 kids in attendance and our church was transformed into a campground adventure area. We received funding from Totten Trail gaming and from GAIA to help cover the costs of the program. These donations are essential to help make the event successful, covering not only the decoration costs, but also the take-home items the kids receive. The main characters (Bella W. & I) help set the theme verse and daily bible point through food, games, stories, music and science experiments. It takes a small army of volunteers to help everything run smoothly and we are truly grateful to the 20+ people who donate their time for the kids. It's almost time to start planning for next year!

### **LYO/LOL**

There is never a shortage of activities for the youth to participate in. This past year was no exception. I continue to help Mrs. Jenny Hirsch at the High School on Wednesdays with FCA (Fellowship of Christian Athletes). We meet twice a month, and we have anywhere from 6-10 kids attending. We've been focusing on different topics this year, from contentment to surrender.

I've tried to meet up with the 6-8th graders once a month and discuss tough faith questions, along with other relevant topics. We also try to host youth group for 6-9th graders once a month.

In June we held our annual rummage sale which raised over \$3500 for our youth activities. In July, three chaperones and I took 17 students to Flathead Lutheran Bible Camp in Flathead, MT. It was

a great learning experience for our kids. They participated in many activities over the course of the week from low & high ropes, to kayaking, to a service project picking up trash alongside a busy highway. The kids were amazing and really participated well in each activity.

In August, our middle schoolers went to Raging Rivers in Mandan. We had 10-15 kids attend the event.

In October, Pr. Janis and I took around two high schoolers and 7-9 middle schoolers to the WND Synod Youth Gathering in Bismarck.

We've also hosted several fundraisers, which we do annually, including the Pancake Breakfast for a C.A.R. classroom, the Baked Potato Breakfast fundraiser and fleischkuechle sales over the Dickens Festival.

The large focus for 2025 was assessing the condition of the church's parking lot and recommending action to the Church Council. This is covered in detail in other reports.

The church yard sprinkler system requires periodic replacement of parts due to damage from snow removal and normal wear. The condition of the lawn is monitored for weeds, etc.

Building maintenance included repairing plumbing fixtures, light switches, and related items. A "to do" list has been started where church staff and council are asking for repair/maintenance items so they can be attended to. These are at the church building and at the parsonage. Work will be completed by volunteers unless it is beyond their ability.

The committee also made sure that furnace filters were changed when necessary and other routine building maintenance.

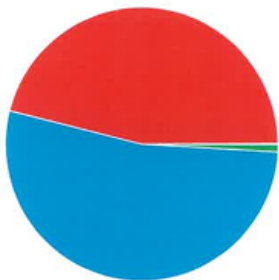

## **CONSTITUTION AMENDMENTS**

### **POWERS OF THE CONGREGATION**

- \*C5.04. This congregation or the Congregation Council shall elect from among its the voting members of the congregation laypersons to serve as voting members of the Synod Assembly as well as persons to represent it at meetings of any conference, cluster, coalition, or other area subdivision of which it is a member. The number of persons to be elected by this congregation and other qualifications shall be as prescribed in guidelines established by the Western North Dakota Synod of the Evangelical Lutheran Church in America.

### **PROPERTY OWNERSHIP**

- \*C7.03. If the voting members of this congregation present at a legally called and conducted special meeting of this congregation vote to transfer; relate to another Lutheran church body, title to property shall continue to reside in this congregation, provided the process for termination of relationship in \*C6.05. has been followed. Before this congregation takes action to transfer/relate to another Lutheran church body, it shall consult with representatives of the Western North Dakota Synod.

### **MEMBERSHIP**

- FYI C8.02.01.. "Contribution of record" means:
  - a. a financial contribution to the congregation during the current or preceding calendar year, which is reflected in the records of the congregation treasurer; or
  - b. a contribution of time or talent to the congregation during the current or preceding calendar year, which is reflected in the records of the congregation secretary (e.g., serving on the congregation council or a congregation committee).
- Voting members are confirmed members. Such confirmed members, during the current or preceding calendar year, shall have communed in this congregation and shall have made a contribution of record to this congregation. Members of this congregation who have satisfied these basic standards shall have the privilege of voice and vote at every regular and special meeting of this congregation as well as the other rights and privileges ascribed to voting members by the provisions of this constitution and its bylaws. They shall not have voted as a seasonal member of another congregation of this church in the previous two calendar months.

### **ROSTERED MINISTER**

- \*C9.01. Authority to call a pastor shall be in this congregation by at least a two-thirds vote of voting members present and voting at a meeting legally called for that purpose. Before a call is issued, the officers, or a committee elected by this congregation when recommended by the Congregation Council to recommend the call, shall seek the advice and help of the bishop of the synod.
- \*C9.02. This congregation may call as a pastor Only:
  - a. a member of the roster of Ministers of Word and Sacrament of the Evangelical Lutheran Church in America; or a candidate for the roster of Ministers of Word and Sacrament who has been recommended for this congregation by the synod bishop may be called as a pastor of this congregation.
- \*C9.21. Authority to call a deacon shall be in this congregation by at least a two-thirds vote of voting members present and voting at a meeting legally called for that purpose. Before a call is issued, the officers, or a committee elected by this congregation with the recommendation of the Congregation Council to recommend the call, shall seek the advice and help of the bishop of the synod.

## **AMENDMENTS**

- \*C16.02. An amendment to this constitution, proposed under \*C16.01., shall:
  - a. be approved at any legally called meeting of this congregation by a majority vote of those voting members present and voting; and
  - b. be ratified without change unchanged at the next regular meeting of this congregation by a two-thirds vote of those voting members present and voting.

## **ROSTERED MINISTER**

- \*C9.06. At a time of pastoral vacancy, an interim pastor shall may be appointed by the bishop of the synod with the consent of this congregation or the Congregation Council.

## **COMMITTEES**

- He believes we should keep this and not remove it. Just do not follow it for now but have a goal to start one.
- o C13.02. A Nominating Committee of six voting members of this congregation, two of whom, if possible, shall be outgoing members of the Congregation Council, shall be elected at the annual meeting for a term of one year. Members of the Nominating Committee are not eligible for consecutive re-election.

## **PARISH AUTHORIZATION** [\* Required provisions when congregation is part of a parish]

- \*C20.01. This congregation may unite with one or more other congregations recognized by the synod named in \*C6.01. to form a parish. Except as provided in \*C20.02. and \*C20.03., a written agreement, developed in consultation with the synod and approved by the voting members of each congregation participating in the parish, shall specify the powers and responsibilities that have been delegated to the Parish Council. The Parish Agreement shall identify which congregation of the parish issues calls on behalf of the member congregations or shall establish a process for identifying which congregation issues calls on behalf of the member congregations.
- \*C20.02. One congregation of a parish shall issue a call on behalf of the member congregations to a minister of Word and Sacrament or a candidate for the roster of Ministers of Word and Sacrament who has been recommended by the synod bishop to serve the congregations of the parish. Such a call shall be approved prior to issuance by a two-thirds vote at a congregation meeting of each congregation forming the parish. If any congregation of the parish should fail to approve the call, the other congregations of the parish shall have the right to terminate the parish agreement.
- \*C20.03. One congregation of a parish may issue a call on behalf of the member congregations to a minister of Word and Service or a candidate for the roster of Ministers of Word and Service who has been recommended by the synod bishop to serve the congregations of the parish. Such a call shall be approved prior to issuance by a two-thirds vote at a congregation meeting of each congregation forming the parish. If any congregation of the parish should fail to approve the call, the other congregations of the parish shall have the right to terminate the parish agreement.
- \*C20.04. Any one of the congregations of the parish may terminate their relationship with the pastor as provided in †S14.18\*9.05.d. of the synod constitution of the synod named in \*C6.01. In such case, the other congregation(s) of the same parish shall have the right to terminate the parish agreement.
- \*C20.05. Any one of the congregations of the parish may terminate their relationship with a minister of Word and Service as provided in †S14.43.d. of the synod constitution of the synod named in \*C6.01\*9.05.d.. In such case, the other congregation(s) of the same parish shall have the right to terminate the parish agreement.
- \*C20.06. Whenever a parish agreement is terminated, the call of any rostered minister serving that parish is terminated. Should any congregation that was formerly part of the parish agreement desire to issue a new call to that rostered minister, it may do so in accordance with the call process of this church.

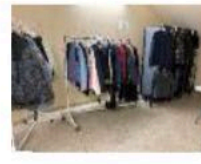
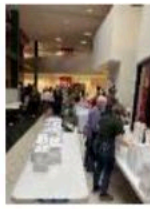

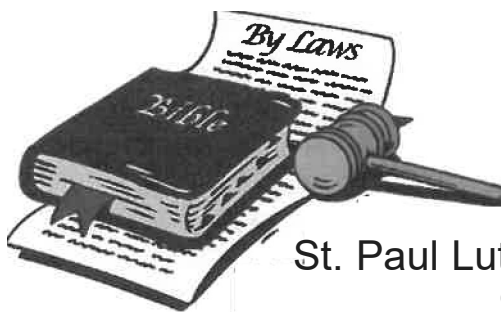
